Meeting called to order at 2:02 pm. David Travis, Dean of College of L&S, addressed the CCC regarding funding the two Graduate Degree Programs at time of budget cuts.

- a. Proposed new Gen Ed Learning Outcomes

Chair Hachten explained history of adopted outcomes; wordsmithing was done. A. Harlan asked about when the new GELOs would become effective and how Gen Ed proposals would be judged during the transition period. She suggested that GERC have statement ready to issue once the GELOs are fully approved.

Killoran/Cartwright moved to recommend that the UCC approve the new GELOs. Motion passed unanimously.
