Resolved that the UW-W course repeat policy for undergraduate students be amended as follows:

From: "Students may repeat a limited number of courses in which they earned a C-grade or below in order to have those grades replaced. During their undergraduate career at UW-Whitewater, students are limited to repeating no more than 5 separate courses for grade replacement."

To: Students who earn a grade of C- or below may repeat the course once for grade and earned credit replacement. Students who wish to enroll in a third attempt of a course must file an approved university appeal. Students should contact the Registrar's Office for information about the appeal process.

Be it further resolved that the revised policy become effective the first day of the Spring 2009 Term.

The University of Wisconsin System Board of Regents on Friday, August 22, approved a budget request for 2009-11 biennium that asks for \$37.5 million in tax money and \$13.4 million in student fees to support the Growth Agenda 2008-2009. The budget also includes \$10 million to recruit and retain faculty. Budget now goes to the State Department of Administration, which is to consider it for Gov. Jim Doyle's executive budget bill, likely to be introduced in February. The Legislature's Joint Finance Committee may begin deliberations in the spring, and lawmakers could consider the plan next summer.
