We the Faculty Senate of UW-Whitewater endorse the TAUWP salary request to help close the gap between the UW-System average pay and average pay at similar public institutions. There is a 9.6% gap at the professor level, and 8% gap at the associate professor level, and a 2% gap at the assistant professor level.

We therefore request that the Board of Regents support nothing less than 8% and 6% salary increases for the next biennium.
