- 7. Announcements and Information (no action unless noted otherwise)
 - 1. Report of the Chancellor: The Chancellor touched on several subjects. He will be holding a campus listening session on the budget on Wednesday, May 6. The Joint Finance Committee which is still reviewing the budget has made several changes to the original financial aid proposals – including reducing the amount of grants, moving aid to the technical colleges, and taking less away from auxiliary accounts. A website is available on campus for questions related to the H1N1 flu virus – several students tested, all negative. The sustainability garden grant and issues related to its implementation have been of concern to the campus. (see information on the Landscape Committee report later in these minutes). The Chancellor was pleased by the display of undergraduate research at the Capitol and the chance for students to interact with their legislators. The new Whitewater Technology initiative is under serious consideration for a grant and some architectural planning has begun. The location will probably be moved the east side of town near the current business park due to wetlands issues at the originally proposed southwest site. Chancellor Telfer received a round of applause in appreciation of his work with the Senate.
 - 2. Report of the Provost: None. Acting Provost Clements received a round of applause in appreciation of her work with the Senate.
 - 3. Report of the Senate Chair: Two items were received too late for the agenda and will be considered by the Executive Committee. First, the Calendar Committee has reconsidered the scheduling of exams after graduation in the spring semester and has offered an amendment to the calendars approved at the April Senate meeting. There was a brief discussion about the reasons for the proposed change. The second item was a report from the Campus Landscape Committee with regards to the sustainability garden by Hyland Hall. The garden is to be split into an International garden and a vegetable garden with the first to be located at the southeast corner of Hyland Hall and the second to the north of Roseman Hall. The Committee has requested from the grantee a business plan, a plan for future maintenance, and a final design plan (with plant legend) in order to receive final approval. The hope is that the International garden will be planted this summer.
