## **Gender-Inclusive Pronoun Recognition and Usage**

**WHEREAS,** Whitewater Student Government serves all students attending the University of Wisconsin-Whitewater; and,

**WHEREAS,** the Student Affairs Director exists to monitor and respond to the needs of a changing campus; and,

WHEREAS, there is a need to recognize LGBT student issues and concerns; and,

**WHEREAS,** Whitewater Student Government understands there are students who do not identify within the gender binary; and,

**WHEREAS**, there is a need to ensure that Whitewater Student Government supports all gender identities; and,

**WHEREAS,** Whitewater Student Government recognizes the word "they" as an acceptable singular, gender-neutral pronoun.

**THEREFORE BE IT RESOLVED,** that Whitewater Student Government will use gender-inclusive pronouns, such as "they," whenever it is deemed appropriate; and,

**THEREFORE BE IT FURTHER RESOLVED,** that Whitewater Student Government supports and strongly recommends that other areas of campus life and governance use gender-inclusive pronouns; and,

**THEREFORE BE IT FURTHER RESOLVED,** that Whitewater Student Government supports and strongly recommends that faculty and instructional staff accept the use of gender-inclusive pronouns, where appropriate, without penalty in their assignments; and,

**THEREFORE BE IT FINALLY RESOLVED,** that this legislation, once passed by Whitewater Student Government, signed by the Whitewater Student Government President, and endorsed by the Chancellor, will take effect immediately and will be communicated to other campus governance bodies.

A. Student Input on Whitewater Farmer's Market

Mr. Erby wants to know when it would be, Ms. Bregant said they are trying to figure it out and that it's all really workable and flexible. They want to compliment the current farm.

Braden Chester said Oshkosh has a similar program as of 4 years. He said it has benefits. He said it revitalized all of the downtown businesses. It became a farmers market, flea market and music festival. He said the downtown is full of businesses because of this market.

No student fees will be going toward this market.

Mr. Grassnickle was concerned of why there were two when they could just join both markets together. Ms. Bregant said no one wanted to step on anyones toes. She said she couldn't provide a concrete answer.

Mr. Erby would like to see it open later, because it's a weekend.

Ms. Kats asked about advertising with the student businesses or students trying to sell their stuff. Ms. Bregant said she would relay it and there at a stage where they're trying to figure everything out.

VP Tomachek is wondering where a venue of this size would take place in the downtown venue. Ms. Bregant said it's open. She said there is nothing set in stone.

Sen. Hartzheim said constituents would like a market during the week because people go home.

Sen. Knudsen was wondering if there was a chance for local businesses or food vendors to eat there, such as food trucks. Ms. Bregant will suggest it.

Mr. Emmett would encourage the city to talk to the Village of Greendale and they have it modeled perfectly where they close down the street. They have the farmers market but they also ask businesses to sell on the sidewalk.

Sen. Murphy said on the music note that he would like to see local bands, student bands and performers to help out artists in the community.

RHA Vice President was wondering if they would consider naming it something other than a farmers market so it wouldn't be a competition.

Ms. Bregant encourages senators to talk to their constituents and give her that feedback.
