 - a. Currently the supplemental item / book purchase limit is \$23/cr. This limit has been the same for at least the last 16 years and is now a significant problem as book and supplemental item prices have increased over the years. Using the CPI inflation calculator (https://data.bls.gov/cgi-bin/cpicalc.pl) \$1 in 2000 = \$1.40 today. In order to provide a reasonable instructional atmosphere, I propose that the maximum price per credit students may be expected to pay be increased from the current \$23 to \$33 and that the bookstore be informed about this change. For example, a 3 cr course could have up to \$99 in supplementary purchases (lab notebooks, workbooks, software, or other items).
