

College of Business & Economics Scholarships

A. Donald Beattie Memorial Scholarship

This scholarship supports a College of Business and Economics student with junior or senior status. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining and have a GPA of 3.0 or higher.

Amount: \$500

Dean's Advisory Council Scholarship

This scholarship will be awarded to students majoring in business who have a GPA of 2.8 or higher. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining.

Amount: \$500

Harish Batra Graduate Scholarship

This scholarship is to reward graduate students in the college of Business and Economics with a GPA of 3.5 or higher. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining. Candidates are not eligible if a company is paying for their education.

Amount: \$500-\$900

Harold and Margaret Perry Scholarship

The Harold and Margaret Perry Scholarship will be awarded to undergraduate students enrolled in the College of Business and Economics who have a GPA of 3.25. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining.

Amount: \$1,000

Helen Harris Wilsmann Scholarship

The recipient of this scholarship shall be a female pursuing her education in the College of Business and Economics with a GPA of 3.25 or higher. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining. The recipient shall be a female US citizen, and have at least 30 hours of college course work.

Amount: \$500-\$1000

The award will be made to a UWW College of Business & Economics student. This scholarship was established by James and Patricia Freer who have both served in administrative positions at UW-Whitewater for many years. Throughout their lives they have been dedicated to service both professionally and in their community. They wish to award UW-Whitewater students who portray the attributes of a "servant leader" and have demonstrated their belief in service to others.

Applicants must be registered students in good standing at UW-W, a sophomore, junior or senior at the time of application, and must have been admitted to the College of Business.

Amount: \$950

Jeffrey Kranz Scholarship

This scholarship shall be made to a UW-Whitewater senior or second-semester junior for one year only who has officially declared a major in management. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining.

Applicants must be full-time students with a GPA of 3.5 or higher, active in student organizations and working to put themselves through school.

Amount: \$1000

Pacific Commonwealth Scholarship

This scholarship will reward any outstanding student with a declared business major. This scholarship will provide one semester's worth of tuition. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining.

Amount: \$2500

UW-W National Alumni Scholarship

This award will be presented to the most outstanding junior in the College of Business and Economics with a GPA of 3.25 or higher. At least 50% of the applicant's credits must be taken at UW-Whitewater. All applicants must have at least one semester remaining. Applicants must exemplify the qualities of scholarship and leadership.

Amount: \$1000

Sentry Insurance Foundation Student Leadership Scholarship

Sentry Insurance has established two leadership scholarships for incoming freshmen at UW-Whitewater who are ranked in the top 10% of their class. The scholarships are designed to help and encourage individuals with proven leadership potential and are available for up to four years, as long as the recipient continues to maintain a GPA of 3.3 or above and continues to pursue a major in business.

Amount: \$2,500

How to Apply: The Dean's Office in the College of Business will send letters to eligible incoming freshmen with instructions on how to apply. Invitation letters are sent in mid-March.

Joseph Domitrz Scholarship

This scholarship will be awarded to an incoming freshman student declaring a business major. Eligible applicants will be in the top 10% of their high school graduating class and exhibit involvement in extra-curricular activities, community activities, charitable organizations and/or other endeavors which indicate significant leadership experience and outstanding leadership potential. Financial need will be considered on an informal basis, especially as a tie-breaking consideration. The scholarship is renewable for up to four years as long as the recipient maintains a grade point average of 3.3 or above and continues to pursue a degree in business.

Amount: \$1000

How to Apply: The Dean's Office in the College of Business will send letters to eligible incoming freshman with instructions on how to apply. Invitation letters are sent in mid-March.

W. Craig Esrael Family Scholarship

This scholarship will be awarded to a student who has declared a major in business, maintains at least a 3.0 GPA and has significant financial need as determined by the Office of Financial Aid. The scholarship is renewable, but the applicant must re-submit an application and complete the selection process each year.

Amount: \$500

John C. Scherer Scholarship

Minority Business Scholarship

This scholarship is awarded to incoming minority freshmen who are pursuing a degree in business. The scholarship is renewable for the sophomore year provided the student maintains a 3.0 or greater GPA and continues to pursue a business degree. The funds to support this scholarship are the result of alumni contributions to the College.

Amount: \$1000 for incoming freshmen and \$500 for continuing sophomores

How to Apply: The Dean's Office in the College of Business will send invitation letters to eligible incoming freshmen in March for the following academic year.

Summer Business Institute Scholarship

This scholarship is available to those students who attend the Summer Business Institute (SBI). SBI is a program to help students of color successfully transition from high school to college at the University of Wisconsin-Whitewater. To attend SBI, Students of Color must be enrolled for the fall semester at UW-Whitewater with plans to major in business. Applicants with cumulative high school GPAs between 2.50 and 2.99 will be given priority. However, an applicant whose GPA does not fall within that range will be considered if space is available. Scholarship recipients must agree to meet with SBI staff and attend SBI group meetings at least twice each semester.

Amount: \$250

How to Apply: Applicants must complete and return the SBI application and essay in mid-May to the Minority Business Office, Hyland Hall 4302. Contact the Minority Business Office for exact date. Applicants must register for and attend Plan It Purple prior to or during the week of the Summer Business Institute.
