History of the RED Form

Special Admission to Professional Education was originally created specifically for the student seeking the six-credit license renewal. However, it is now also applicable for students who desire to take upper level education course(s) but who have no intention to use it to seek an additional or first time teaching license.

Special Admission to Professional Education is typically limited to six credits and will be approved for one semester only. If you wish to take a course during an additional semester, another form must be submitted for approval. (NOTE: Communicative Disorders, School Psychology, Transitional Needs, and Physical Education Non-Licensure programs are allowed to complete their program regardless of number of credits.)

If you hold a "regular" teaching license, attach a copy of the license(s) or attach a copy of the DPI data base indicating your licensure area(s). Permits and 1-year licenses are not considered regular licenses.

Students who fall under the following categories should read carefully before signing:

1) Licensed teacher taking six credits of refresher work; 2) Physical Education Non-Licensure major only; 3) Special Education Minor (attached to a non-education majors); 4) Transitional Needs Program; 5) Communicative Disorders undergraduate program; and, 5) Non-Education major seeking to take education course(s)

I am not seeking endorsement from UW-Whitewater. I understand that if I should seek a first or additional UW-W endorsement at a later date, all requirements for Professional Education must be met and I must submit a completed application for admission to Professional Education. I am also aware that UW-W program coordinators may, but are not obligated to, use the courses taken under the non-licensure or renewal admission. If I am pursuing the undergraduate Communicative Disorders program, I understand that my undergraduate program is a non-licensure program. I must complete the Communicative Disorders graduate program for licensure.

Students who fall under the following categories should read carefully before signing:

1) School Psychology Program and 2) Communicative Disorders Graduate Program

I am seeking endorsement from UW-Whitewater in a Master's Program of School Psychology or Communicative Disorders. I understand that if I should seek another licensure area at a later date, all requirements for Professional Education may need to be met and I may need to submit a completed application for admission to Professional Education. I also am aware that other UW-W program coordinators may, but are not obligated to, use the courses taken under this Master's Program.

Important to the Student who falls under the following category:

Special Education Minor (attached to an education major)

I am seeking endorsement from UW-Whitewater in an education major. I have chosen Special Education as my minor. I understand that I may be accepted with special professional education admission for one semester only. This will allow me to take Special Education courses for my minor. My admission status will be removed after the designated pre-registration time listed on the UW-Whitewater Academic Calendar. To continue with upper level education course, I must submit a completed application for Admission to Professional Education for my education major area. I understand that if I should seek Special Education licensure at a later date, program coordinators may, but are not obligated to, use the courses taken under this minor program.
