- Gave a brief history of Rock county
 - Regionalization process related to budget crises
 - Restructuring process causing "identity crisis" and main campus tensions
 - The future is looking brighter
 - Opportunities a leader in inclusive education for people needing access to higher education
 - Reinstituted FYE and bridge programs (e.g., math boot camp, growth mindset programs)
 - Programs athletics, collaboration with Edgewood college allowing priority access to nursing program, partnership with Blackhawk tech, business degree possibility, accelerated degree programs, shared housing for students who live on main campus and travel to Rock campus
 - Becky Jones mentioned another nursing program partnership on another campus (missed which one)
 - David asked question about advertising main campus summer course
 - Mike noted that it is good to have some positivity on Rock campus because optimism has been lacking over the years
- Discussion: AS Promotions Committee Policy Draft (Chair: Tumbarello)
 - Terry introduction of the process, why it is important at this time (administration is invested NOW), recognition that this policy may need to evolve over time, how this process will differ from the IAS promotions process and why that is needed given differences in titling and budget streams
 - HR has reviewed already and made sure that there are no violations of state statute
