WHEREAS, Thomas Drucker received the Mary Pinkerton Spirit Award from the College of Letters and Sciences; and

WHEREAS, Thomas Drucker was the advisor of the Student Math Association, the Pi Mu Epsilon Mathematics Honor Society, the Table Tennis Club, the Jewish Student Organization, and the Chess Club; and

WHEREAS, Thomas Drucker is the many time champion of Intramural Tennis and Table Tennis tournaments; and

WHEREAS, Thomas Drucker was nominated for the Academic Staff Excellence Award; and

WHEREAS, Thomas Drucker chaired the Philosophy of Mathematics special interest group of the Mathematical Association of America; and

WHEREAS, Thomas Drucker chaired the Wisconsin Section of the Mathematical Association of America; and

WHEREAS, Thomas Drucker represented Wisconsin to the Congress of the Mathematical Association of America; and

WHEREAS, Thomas Drucker received the Distinguished Teaching Award of the Wisconsin section of the Mathematical Association of America in 2019; and

WHEREAS, Thomas Drucker taught 14 years at MathPath, an international summer program for gifted middle school mathematics students, lecturing on history of mathematics and other topics; and

WHEREAS, Thomas Drucker organized many conference sessions on Philosophy of Mathematics for both the American Mathematical Society and the Mathematical Association of America; and

WHEREAS, Thomas Drucker presented many times in national meetings of the Mathematical Association of America; and



WHEREAS, Thomas Drucker was always available to offer his hospitality, help, and a sympathetic ear to faculty, staff, and students in the department, and he is very much missed; and

WHEREAS, Thomas Drucker demonstrated professional commitment, dedication and loyalty to the University of Wisconsin-Whitewater; and
