NOTE TO APPLICANTS: The University conducts criminal background checks for all new hires. A criminal conviction or pending **criminal** charge may be a factor in the hiring decision. An actual check of conviction records and/or pending criminal charges will be conducted only if you are a finalist for the position.

The information requested below is required to conduct a criminal history background check and will not be used for any other purpose. Discrimination on the basis of age, gender, race or any other protected class status is prohibited by University policy.

A record of conviction and/or pending criminal charges is not an absolute bar to employment. Such information will be considered only if there is a substantial relationship between the circumstances of the conviction and/or pending charge and the position being applied for. Your completion of this form is part of your application process. Applicants must fill out the form accurately and completely, to the best of their knowledge, disclosing all convictions and/or pending criminal charges for any felony or misdemeanor. Applicants who fail to complete and return the form in a timely fashion will not be further considered for employment.

UW-Whitewater requires employees to report any criminal arrests, charges, or convictions (excluding traffic offenses punishable only by fine) to Human Resources or University Police Services within twenty-four (24) hours or at the earliest possible opportunity. Failure to make the required report may constitute a violation and may result in disciplinary action, up to and including dismissal.

An applicant's failure to accurately and completely disclose his or her criminal conviction history may be grounds for removal from further consideration for a position.
