- 3. Discussion: GERC draft proposal to restructure the Gen Ed elective categories (proposal handout).

The draft proposes several changes to the Gen Ed categories (abolish GI and GP categories; create new GG (Global) and GW (Wellness) categories; rename and expand scope of existing GE category). Categories do not belong to a particular department. Categories are more about breadth and are to avoid students taking all electives in major area.

Will need a formal proposal to go through and is tied to the Recertification timeline discussion below.

4. Discussion: Tentative timetable for Diversity and General Education Recertification (distributed)

Procedures: The request for recertification will be administered through CourseLeaf. The form will be modified so answering yes to "Fulfills U.S. Racial/Ethnic Diversity requirement" or "Course satisfies a general education elective" will prompt the proposer to select options. In the case of Gen Ed, the proposer will also be prompted to choose the relevant new GE elective category.

Applicants for recertification will need to answer several questions similar to those required for a new application for Gen Ed or Diversity designation. Questions still under development. Will use a Qualtrics survey for answers, on a separate linked webpage TBD.
