

Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white to pale yellow. **Danger!** Corrosive. Highly toxic. Oxidizer. Maycause kidney damage. Poison! May cause central nervous systemeffects. Causes eye and skin burns. Causes digestive and respiratorytract burns. May cause reproductive and fetal effects.

Target Organs: Kidneys, central nervous system.

Potential Health Effects

Eye: Contact may cause severe eye irritation and possible eye damage. **Skin:** Causes skin burns. May be absorbed through the skin in harmful amounts.

Ingestion: May be fatal if swallowed. Poison by ingestion. Causes gastrointestinal tract burns. May cause kidney damage. May cause methemoglobinemia, cyanosis, convulsions, and death.

Methemoglobinemia is characterized by dizziness, drowsiness, headache, breath shortness, cyanosis with bluish skin, rapid heart rate and chocolate-brown colored blood. May cause adverse nervous system effects and possible damage. The effe cts may be delayed.

Inhalation: May cause methemoglobinemia, cyanosis, convulsions, tachycardia, dyspnea, and death. May cause severe irritation of the respiratory tract with sore throat, coughing, shortness of breath and delayed lung edema. May cause effects similar to those described for ingestion.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower lids. Get medical aid immediately.

Skin: Get medical aid immediately. Immediately flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes. Destroy contaminated shoes.

Ingestion: Do NOT induce vomiting. If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Get medical aid immediately. Remove from exposure to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

Notes to Physician: Treat symptomatically and supportively. **Antidote:** The use of Dimercaprol or BAL (British Anti-Lewisite) as a chelating agent should be determined by qualified medical personnel.
