
Re: Fiscal Year 2021 UW System Administrative Policy Priorities

The purpose of this memorandum is to provide an accounting of the policy work completed in fiscal year 2020 and to notify institutions of the University of Wisconsin System Administrative (SYS) policies and procedures that are scheduled for revision or development during fiscal year 2021. A listing of the institution distribution dates for fiscal year 2021 is provided at the end of this memorandum.

In fiscal year 2020, 11 new SYS policies and 33 SYS policy revisions were approved by the UW System President. Additionally, seven (7) new SYS procedures and eight (8) SYS revisions to existing SYS procedures were approved by UW System Vice Presidents. There were also four (4) new guidance documents published, in addition to seven (7) SYS policy rescissions. Outside of this, 14 interim policy actions were approved because of the COVID-19 pandemic. In total, 84 policy, procedure, and guidance actions were approved during fiscal year 2020.

Furthermore, UW System Administration undertook multiple initiatives to enhance the policy process and improve communication with stakeholders across the UW System. This work included:

- the publication of a Policy Style Guide to assist policy owners and standardize the drafting of policy documents;
- the development of an interim policy process to address the emerging needs of the COVID-19 pandemic; and
- the standardization of delayed effective dates for policies that require additional time for implementation. When a policy owner determines that a policy requires a delayed effective date, this is communicated during the policy distribution, once the policy is approved, and in the month prior to the policy's effective date. Delayed effective dates must fall on the first of the month for the ease of policy owners and those who implement policies on campuses.



Below is a list of SYS policy priorities for fiscal year 2021. They have been identified as high priority due to the policy's content, the last revision date, or other emergent factors (e.g. changes to federal or state regulation). Institutions were asked to provide input on SYS policy priorities that should be undertaken by UW System Administration in the coming year.

These comments were provided to policy owners for final consideration in the development of this plan. Our thanks to your staff for their time in developing the attached priorities.

For fiscal year 2021, UW System Administration has narrowed the list of substantive policy priorities in recognition of the additional workload on campuses in response to COVID-19. When able, the quarter that the policy work is expected to begin is indicated to allow institutions the ability to plan and allocate resources comment on draft policies. Not all offices were able to project workloads and/or timelines of policy development.

The list below is not exhaustive, as other issues may arise as the fiscal year progresses, leading to other policy matters taking precedence. For example, further interim policy actions may be taken in response to the continued challenges of the COVID-19 pandemic. Additional policies may also emerge as the Administrative Transformation Program (ATP) moves forward.
