WHEREAS, Michael D. Wallace oversaw the field educational experiences of social work students for 18 years; and

WHEREAS, Michael D. Wallace actively participated in academic and professional advising of undergraduate social work students; and

WHEREAS, Michael D. Wallace won the Outstanding Advising Award in 2001; and

WHEREAS, Michael D. Wallace won the Outstanding Faculty Teaching Award and Faculty Service Award in 2002 and was nominated for the Roseman Academic Staff Excellence Award-Instructional for 2003-2004; and

WHEREAS, Michael D. Wallace developed the Social Work with Children and Adolescent classes in the social work department; and

WHEREAS, Michael D. Wallace tirelessly advocated for the rights of social workers, including talking to legislators, taking social work students to Lobby Day at the state capital; and

WHEREAS, Michael D. Wallace served as a faculty advisor to the Social Work Student Organization, during which time the organization won the Chancellors Achievement Award by the Center for Student Involvement in 2002; and

WHEREAS, Michael D. Wallace assisted the department by coordinating the field program, including developing partnerships with a significant number of community agencies; and

WHEREAS, Michael D. Wallace presented at numerous state and national social work conferences; and

WHEREAS, Michael D. Wallace was awarded the 2014 Distinguished Social Work Award by The National Association of Social Work; and

WHEREAS, Michael D. Wallace continued to serve the public through his outpatient social work counseling at Cornerstone Counseling Services in Milwaukee, WI; and

WHEREAS, Michael D. Wallace represented the University of Wisconsin-Whitewater by serving as President of the Wisconsin Council of Social Work Education; and

WHEREAS, Michael D. Wallace represented the University of Wisconsin-Whitewater by serving on various committees on the National Association of Social Work Wisconsin Chapter; and

WHEREAS, Michael D. Wallace has served on the Academic Staff Assembly, Alpha Delta Mu/Phi Alpha Honor Society, Student Standards and Support Committee; and

WHEREAS, Michael D. Wallace served as a consultation to La Causa and Next Door Foundations in Milwaukee, WI
