### Proposal for 2020-2021: Requirements

- 1. Audition for area faculty to determine # of semesters of applied study and/or ensemble participation. This may include jury requirements and senior recital depending upon audition, undergraduate degree, and experience at the discretion of the areas.
- 2. Audition on piano with piano faculty to determine piano coursework. Required piano coursework could be waived if the piano proficiency requirements are met. It could also include up to 6 semesters of piano coursework **and** proficiency test requirements.
