## **B.** Announcements:

-Guest speaker, Kris Curran, Biology, introduced the Applied Biotechnology (ABT) online Master of Science program that is a collaboration with seven campuses. Kris is the Academic Program Director and will work with students as their advisor. Each individual university will provide the degree with most students expected to choose the closest location. The goals is to have the program approved by HLC and BOR by February 1, 2019 and classes offered in Fall 2019. UW-W is responsible for only two courses; however, every class will be in the course catalog. These courses will appear for approval at the next CCC meeting.

-The General Education Review Committee reminds all departments that the gen ed elective recertification process will conclude at the end of the fall semester. GERC also notes that some proposals are being sent back to the original proposer for one or more of the following reasons: 1) the Qualtrics survey is not completely filled out (some questions require the user to scroll across to see all the elements); 2) the GERC expectations for syllabi have been ignored (for details available at <a href="http://www.uww.edu/gened/instructors/syllabus\_guidelines">http://www.uww.edu/gened/instructors/syllabus\_guidelines</a>); 3) internal inconsistencies between the information provided in the survey and on the syllabus. Links to GERC's rubrics for evaluating proposals will be posted on the L&S CCC website. And note that our own Jeff Zimmerman will serve as the GERC Chair this year.
