### D. Geography, Geology, Environmental Science

#### 1. Course Revision [Geography 452: Cultural Ecology and Sustainable Development](#)

- a. Jeff Zimmerman motioned D1 course revision for 452. Seconded by Angela Harlan. This is just a pre-requisite change.
  - i. Discussion-Ellen Davis asked if Biology 214 is being added as a prerequisite. Jeff is not sure-we need to talk directly to Eric Compas. As long as Ellen Davis approves of the proposal, Jeff will talk to Eric. This will not be sent forward until we know about the prerequisite. Eric will need to contact Mary to explain the 214 reasoning.
- b. Motion passed unanimously.

2. Course Revision [Geography 420: Climate Change: The Science and Impacts](#)
  - a. Zimmerman moved D2 seconded by Zach Oster. GERC will make determination about this being a GenEd course. Proposal approved and motion passed unanimously.

## **E. Math**

1. Course Revision [Math 140: Mathematical Ideas](#)
  - a. Harlan moved to approve, seconded by Paddock to approve. Harlan explained the corequisite option for the course.
  - b. Discussion: none
  - c. Motion approved for E1, no opposition. Motion passed unanimously.
2. Course Revision [Math 471: Numerical Analysis](#)
  - a. Harlan moved approval seconded by Oster. No discussion. All in favor, none opposed. Motion passed unanimously.
3. Program Revision [Mathematic: Math Minor](#)
  - a. Harlan moved E3 seconded by House. Harlan explained the revision to include the words "and Stat." All in favor, motion passed unanimously.
4. Program Deactivation [Mathematics-Applied Mathematics Emphasis \(BA/BS\)](#)
5. Program Deactivation [Mathematics- Pure Mathematics Emphasis \(BA/BS\)](#)
  - a. Harlan moved to accept E4 &5, seconded by Davis. Harlan explained the deactivation of both programs. This is a better way for students to have more flexibility. These two programs have been combined to create the new program. Students will still be able to take these if they are in the program.
  - b. Discussion-none
  - c. Motion passed unanimously.

## **F. Social Work**

- a. New Program [Substance Abuse Counselor in Training Certificate](#)
  - i. Hessenauer moved, seconded by Gregory to accept Fa & b. Hessenauer explained that Fa is the first SW certificate for students to earn in the state of WI. Gregory added more explanation about the certificate programs. This allows working with people in recovery, not to be a counsellor. Copy and paste error Sociology Internship 493 needs to be added. (Substitute 493 for 492.)
- b. New Program [Certificate in Substance Abuse Counseling](#) (Graduate)
  - i. Hessenauer explained this is for the Masters level. There are 2 electives including two addiction courses. The internship has to be in addictions. Hachten asked for explanation of structure of required and elective courses. Hessenauer explained this is required just for the certificate. Hachten requested this be required on the introductory level certificate.
  - ii. Table this proposal-students who do not have a BSW may need to do these prep courses. This may already be required. Unique requirement will need to be set up so it is clear that most students do not have to do it. The required courses are the program. The other courses are not. This requires a total of 23 credits.
  - iii. Hessenauer will bring the proposal back at the next meeting.
  - iv. Discussion: Outcomes are the same as required by the State. Hachten-no assessment is required for certificates.
  - v. Hessenauer will make the changes that are necessary.

1. Hachten: Insert the word "Graduate" into the certificate (Graduate certificate in substances).
- vi. Hachten and Pratt will work with Hessenauer to make modifications of minimized language and unique requirements.
- vii. Harlan-23 credits is a lot for a certificate. Hessenauer-Most classes apply to the major, only an additional 6 credits. Students in the major will get the certificate with the extra 6 credits.
- viii. Motion passed for F1&2.
