D. Letters and Science

1. Course Change [LSINDP 399: Career Information in Letters & Sciences](#)
 - a. Moved by Jeff Zimmerman and seconded by Ted Gimbel.

- b. Susan Johnson explained the course grading. This will be an incentive and also a way to reward good behavior. Ellen Davis-Why not add minors also? The committee agreed. Jeff Zimmerman moved to amend the motion to include declared majors or minors in the College of Letters and Sciences. Course description will need to be updated also.

E. Psychology

- 1. Course Change [PSYCH 215: Basic Statistical Methods](#)
 - a. Math 141 has not been deactivated, but is not being offered. It is however being left in the curriculum. This course helps U-Rock students when they transition to our campus. And it helps transfer students who bring in a course that is equivalent to Math 141.
 - b. If there are prereqs with Math 141, it's fine.

 - b. David Havas explained the course changes. This is meant to improve enrollment overall.
