Approval of Minutes

Announcements

COBE International Requirements (Susan Johnson)

- Susan explained the change being presented. This will affect courses designated as an international requirement. This procedure will be implemented in the Fall.
- Leda Kanellakou asked if travel Studies are included in the GG Designations. Angela: Not automatically. This needs to be reviewed by the Gen. Ed. Review Committee.
- Ellen Davis asked if COBE could add 491 (International travel) as a GG. Angela: Possibly.
- David Havas: There is a new HLC policy regarding substantive changes to programs and there is a new system to report on these changes. Angela: We will need more information on this. Zach, is there a document for UCC regarding this? Zach Oster: No, there is no new document.
- Angela: An HLC change that has been made with changes being made to the program of the entire degree for the major. There is now a 25% threshold. If the change is over 25%, it has to be reported. We will need more clarification on this; there is uncertainty as to when these changes need to be reported. Answering "No" will be used often. Zach: the response will have no impact on what the UCC does with the proposal. Angela: If the change is over 25%, it gets reported to the HLC. The HLC will then look at the program and determine whether it needs to be re-evaluated.
- Zach: This change will have a great impact on Graduate Programs and Certificates.

SCA has obtained approvals from all departments involved. Students may take up to three courses. All nine from Anthropology, or six from Anthropology and three from the other choices in alternate disciplines.
