 - Wesley Hough moved to accept D 1-4, seconded by Ellie Schemenauer.
 - Janine Tobek explained the course revisions. For the graduate courses there was discussion of the grade basis, the purpose of the courses, the students the course serves, and the number of students taking them. There was inconsistency in the prerequisites. The prerequisite for ENGLISH 571 was removed at the request of the proposer. For the undergraduate courses there was a lengthy discussion about whether to keep the ENGLISH prefix and adding a cross-listing with PWP or change the prefix to PWP, eliminating the ENGLISH prefix for these courses. The decision was to continue with the change in prefix.
 - Vote: Motion passed unanimously. No abstentions.

G. POLITICAL SCIENCE

 - Ted Gimbel moved to accept G-1, seconded by Paul Adogamhe.
 - Ted explained the course proposal.
 - A question was raised about the budgetary impact to staffing. The proposer is a newer faculty member who was intended to incorporate new courses.
 - Vote: Motion passed. No abstentions.

H. Public Health Minor

 - Ellie Schemenauer moved to accept F-1, seconded by Adam Paddock.
 - Angela Harlan explained the prefix changes on the proposals from last week to change English to PWP.
 - Vote passed unanimously, no abstentions.

 - Ellie moved to accept G-1, seconded by Leda Kanellakou.
 - Sarah discussed this at the last meeting, but the proposal had not been submitted yet.
 - It was suggested that the title should be Post MSW School Social Work Certificate, which is consistent with other certificates. Angela will verify this with Sarah and make the change to CourseLeaf.
 - Vote passed unanimously with no abstentions.
