- Kristen Prock moved to approve G1-2, seconded by Zach Oster. Kristen explained the proposal revisions. Description changes provide more clarity. Ellen Davis had a question about the 733 course description. Passed unanimously with no abstentions.

 - Kristen Prock moved to approve G3, seconded by Wesley Hough. Kristen explained that 778 will be an all-clinical course. Passed unanimously with none opposed, no abstentions.

 - Kristen moved to approve G4, seconded by Zach Oster. Kristen explained the program revision. Susan Johnson added that in the form, there is a question about the percentage of change to the course or program. This percentage is out of the total (120 for undergrad for example). Angela Harlan suggested checking with Kristen Plessel for clarification. If you are adding to a course or program it is allowable to say “no change.” If the change is 25% or more, HLC needs to be notified. This has less of an impact on undergrad programs than graduate programs. Ellen Davis asked if changes are cumulative. Angela Harlan answered, yes, however it is unclear over what time frame is considered. Passed unanimously, none opposed, no abstentions.

Discussion

1. Information discussion of Broadfield Science BSE
 - Ellen Davis explained the DPI changes to grades 4-12 Science teacher requirements. With the BSE, graduates will be able to instruct any of the sciences.
 - Changes include 120 credit-requirement plus licensure.
 - Ellen explained they do not want to put student teaching as a requirement in the major (additional 12 credits). Licensure is separate from content, and separate from a minor.
 - Ellen explained the difficulty of keeping the credit-requirement at 120 or below.
 - There was much discussion about an emphasis and the BSE major in general.
 - Susan Johnson noted that proposals relating to these majors will be coming through very soon.
